



# iLearn Student Participation Agreement

## General Use

1. I have read and I understand the information provided in the iLearn Program Charter.
2. I understand it is recommended that I bring my iPad to school each day.
3. I will ensure my device is charged at the beginning of each school day.
4. I will leave my device charger at home unless directed to bring it to school under special circumstances.
5. I will hold my device with two hands when carrying it and will walk with it at all times.
6. I will bring my device into the classroom at the start of each day. It is strongly recommended that the device has a robust protective case suitable for student use.
7. I will only use my iPad at school. I **do not** have permission to use another student's iPad.
8. I will only use my iPad within the classroom whilst at school. I require permission from Narangba State School staff to use my iPad at other locations within the school.
9. I will keep food and drinks away from my device at school.
10. I will immediately report any accidents or breakages to my parents and teachers.

## Content

11. I will use the device only to support my school learning program whilst at Narangba State School.
12. I will download and use the Narangba State School Apps at school to support my learning. If I download any other apps they will be stored in a 'home folder'.
13. All Cloud applications will be turned off while I am at school. E.g. iMessage, iCloud, streaming.
14. I understand that some of my work will be shared with my teacher using OneDrive, Seesaw, Teams, OneNote, Air Server and school email, and teachers will use Apple Classroom for management and sharing.
15. I agree to join my teacher's Apple Classroom and understand they will use this app to manage my device and share my work. I will select "Always Allow" for my teacher to access my device, and I will not change these settings.
16. I am not permitted to use the Internet at Narangba State School to download non-learning related audio/video files, website content music, television or apps.
17. I am responsible to ensure my device is backed up at home.
18. I am responsible to ensure my app updates are completed at home. The Narangba State School Internet network cannot be used for app updates.

## Safety and Security

19. Whilst at school, I will only connect my device to Education Queensland's Managed Internet Service. I am not permitted to access the internet using mobile data.
20. I will have my iPad turned off and all apps and webpages closed before and after school. My iPad will remain in my bag before and after school.
21. Whilst at school, I will only go to websites and apps, which support my learning activities.
22. I will be Cybersafe and Cybersmart when using the iPad and Internet. I will demonstrate care for others when using my device.
23. I will not record, photograph or film any staff or students without the express permission of the individual/s concerned and the supervising teacher.
24. I will use the device lawfully and in accordance with the iLearn Program Charter, School Code of Conduct, and the Appropriate Use/Behaviour of School Network guidelines regarding ethical use of equipment, technology, use of legal software, use of the internet and the protection of personal data.
25. For security reasons, I am not to share account names and passwords with anyone unless requested by Narangba State School staff.
26. I am responsible for the security and use of the device while at Narangba State School.

## Overall

I understand if the above conditions are not followed, consequences will be issued. I understand that if I breach the iLearn Student Participation Agreement, authorisation to use my device at school will be removed.
